**1. METHOD OF RECRUITMENT**

Selection of Candidates will be made in accordance with the provisions of the Karnataka Subordinate Courts (Ministerial and Other Posts) (Recruitment) (Amendment) Rules 2007.

The Driving Test will be conducted for candidate who has applied for the post of Driver to ascertain their expertise or skill in Driving.

**2. PROBATION:**

Selected candidate will be appointed on Probation for a period of two years and the provision of Karnataka Civil Services (Probation) Rules, 1977 shall MUTATIS MUTANDIS apply to be candidates so selected.

**3. QUALIFICATION**

- a) The candidate must have passed SSLC Examination or equivalent examination.
- b) Must be holder of Current Light and Heavy Driving Licence.
- c) Must be able to read and write in Kannada.

**4. SCALE OF PAY**

**Rs.**11600-200-12000-250-13000-300-14200-350-15600-400-17200-450-19000-500-21000 with admissible allowances.

**5. AGE LIMIT**

Candidate must have attained the age of 18 years on the last date fixed for receipt of applications through online must have not attended the age of:

- a) 40 years in case of persons belonging to SC/ST or Category-I.
- b) 38 years in case of persons belonging to any of the Category II-A/II-B/III-A/III-B or other Backward Classes.
- c) 35 years for others.

**6. DRIVING TEST:**

Applicants, when called for driving test must appear at their own expenses, at the placed fixed for such test.

**7. CANDIDATES CLAIMING RESERVATION.**

Candidates, who are in service of Union of India/State Government and their undertaking should posses the "No Objection Certificate" issued by the concerned authority at the time of verification of documents/further tests.

8. The Candidates called for the Documents Verification and Interview, shall furnish the necessary original documents with regard to the Educational Qualification, Caste, Date of Birth, Reservation Claimed, if the information furnished by the candidate in the application is found to be false, then their candidature is liable for rejection and also they are liable for criminal prosecution for furnishing false information.

## 9. **MODE OF APPLICATION AND FEE:**

The method of Application shall through **Online** on the <http://ecourts.gov.in/dharwad/online-recruitment> OR <http://karnatakajudiciary.kar.nic.in/districtrecruitment.asp>

To be applied as per the instruction made available in the website. **Application sent by any other mode other than online will not be considered.**

- a) The candidate shall pay an Application Fee of Rs.200/- (Rupees two hundred) prescribed for the post, any of the following mode of payment. The candidates belonging Category-I/ Schedule Caste/ Schedule Tribe shall pay fees of Rs.100/- (Rupees hundred only)
  - (i) **Online Payment:** On submission of online application the candidate shall make the online payment by clicking "Make Payment" option.
  - (ii) **Challan Form:** On submission of online application the candidate shall download the challan through the SBI online Payment gateway link <http://ecourts.gov.in/dharwad/online-recruitment> in PDF format and shall remit the prescribed fee in any branch of SBI. (System needs to support PDF reader-like Adobe, Acrobat).
- b) Candidates have to enter correctly their Reference Application Number and other details such as name, date of birth and mobile number in State Bank of India Payment Page.
- c) Fee once paid will not be refunded under any circumstances.
- d) Regarding payment of application fees. Banking related queries/ clarification please contact concerned SBI Branch.
- e) After successful online payment, candidates should save a copy of receipt for their future reference and they need not scan and upload the receipt.
- f) Candidates paying through offline/SBI Branch payment need not scan and upload endorsed challan in the website after successful payment of fees. Candidates to retain the paid challan for their future reference.
- g) Candidates, who are in service of Union of India/State Government and their undertaking should possess the "No Objection Certificate" issued by the concerned

authority at the time of verification of documents/  
further tests.

- 10.** The candidate who attempt to obtain extraneous support by any means for candidature shall not be eligible for appointment.
- 11.** The candidate shall possess the following certificates mentioned below issued by the competent authority on or before the last date of applying through Online and have to submit at the time of verification of documents called for the test/interview.
  - a) Three Character Certificates (one from the last studied education Institution and 2 from the respectable persons) at the time of document verification.
  - b) Self attested copy of SSLC Marks Card in support of age proof.
  - c) Citizen Certificate (where the candidate is not a citizen of Indian by birth) issued by the DC/District Magistrate of the District in which the candidate is residing.

**General instructions to the candidates. candidates shall follow the below mentioned instructions compulsorily before filling up of the application through online:**

- 1) Candidates shall read all the instruction carefully before submitting online application, so as to avoid the mistakes/rejections.
- 2) Candidates shall provide the Mobile Number (Compulsorily) and valid E-mail ID (if any) for communication at relevant columns while submitting online application. The authority is not responsible for non-receipt of SMS or e-mail.
- 3) Candidates shall provide photograph and signature scan separately. The candidates shall scan his/her latest passport size photograph with white background (having 5cm length X 3.6cm of breadth with maximum size 50kb in jpg format) and signature on white paper in black point pen (having 2.5cm length X 7.5cm of breadth with maximum size 26kb in jpg format) separately and upload the same, while submitting the online application.
- 4) Print out submitted application form and the copy of payment receipt/challan has to be preserved by the candidate till completion of recruitment process.

- 5) To avoid last minute rush, the candidates are advised to submit the Online applications well in advance. The website will accepted the applications round the clock till 11:59 p.m. on 08-11-2017

**Last dates:**

- (a) To register/submit online applications is on or before 08-11-2017.
- (b) For online payment of fee through **Net Banking/Credit/Debit** and also **Generation of Challan** is on 10-11-2017
- (c) To remit **Challan Form** to **SBI Branch** is on 10-11-2017

- 6) Intimation will be sent to the eligible candidates through SMS and e-mail provided. The list of eligible candidates for interview or Test will also be notified in District Court, Dharwad website URL link <http://ecourts.gov.in/dharwad/online-recruitment>

for downloading the call letter. Candidate must bring his/her Call Letter for Tests/Viva-Voce.

- 7) The candidate called for tests/viva-voce will have to appear for the same at their own cost.
- 8) The candidate shall obtain the prescribed forms of below mentioned certificates before the last date for submitting online application from the concerned Competent Authorities and shall produce all the original testimonials at the time of verification during Interview. The certificate obtained after the last date fixed for submitting online application will not be considered.
- a) Online submitted application printout.
  - b) The copy of application fee paid receipt/challan.
  - c) The SSLC showing the date of birth.
  - d) No Objection Certificate (in service candidates).
  - e) Caste Certificate, if reservation claimed under SC/ST/Cat-I/II-A/II-B/III-A/III-B in prescribed formats issued by the Competent Authority.
  - f) The discharge certificate from military service (Ex-Serviceman), if reservation claimed.
- 9) While applying online application for the post, the Candidate shall ensure that, he/ fulfils the eligibility and other norms as mentioned above and that all the particulars furnished by him are correct in all respects. In case, if it is detected at any stage of recruitment that, candidate does not fulfill the

eligibility norms and/that he has suppressed/twisted or truncated any material facts, his candidature shall stand cancelled. If any of these short comings is detected even after appointment, his appointment is liable to be terminated. Furnishing of wrong, incomplete and incorrect information would not only lead the disqualification but the candidate is also liable for criminal prosecution.

- 10) The candidate shall not upload any of these original or attested copies of documents/certificates at the stage of submitting the online applications.
- 11) The candidate shall produce all the original testimonials along with one set of photocopies at the time of verification during the interview.
- 12) If any candidate is found attempting/obtaining extraneous support by any means of candidature from any official or non-officials, he/she will not be eligible for appointment.
- 13) There will be increase of decrease in the post of Driver.
