**NOTIFICATION**

In exercise of the powers conferred by Sub-para (1) of Para 4 and Sub-para 5 read with para 15 of the Karnataka Public Employment (Reservation in Appointment for Hyderabad-Karnataka Region) Order, 2013, the Government of Karnataka hereby makes the following rules to amend the Karnataka Public Employment (Reservation in Appointment for Hyderabad-Karnataka Region) (Organization of Local Cadre, Allotment and Transfer of Persons) Rules, 2013 published in part-IVA of the Karnataka Gazette dated: 29.01.2014, namely:-

**THE KARNATAKA PUBLIC EMPLOYMENT (RESERVATION IN APPOINTMENT FOR HYDERABAD-KARNATAKA REGION) (ORGANIZATION OF LOCAL CADRE, ALLOTMENT AND TRANSFER OF PERSONS) (AMENDMENT) RULES, 2014**

**1. Title and Commencement.-** (1) These rules may be called as the Karnataka Public Employment (Reservation in Appointment for Hyderabad-Karnataka Region) (Organization of Local Cadre, Allotment and Transfer of Persons) (Amendment) Rules, 2014.

(2) They shall come into force from the date of their publication in the official gazette.

**2. Amendment to Rule 6.-** In the Karnataka Public Employment (Reservation in Appointment for Hyderabad-Karnataka Region) (Organization of Local Cadre, Allotment and Transfer of Persons) Rules, 2013, in rule 6:-

- (i) in sub-rule (1), for the figures and word "30 days" occurring in two places the figures and word "45 days" shall respectively be substituted; and
- (ii) after sub-rules (1) the following shall be inserted, namely:-

“Provided further that in case of employees who have not exercised their option within thirty days from the date of notification under sub-rule (1) before the date of commencement of the Karnataka Public Employment (Reservation in appointment for Hyderabad-Karnataka Region) (Organization of Local Cadre, Allotment and Transfer of Persons) (Amendment) Rules, 2014 may exercise their option within 45 days from the date of commencement of the said amendment rules.”
